WHEREAS to acknowledge the efforts to bring awareness to the continuing evolution of the 2SLGBTQIA+ Pride movement, the Municipality of Mississippi Mills will display the Progress Pride Flag, representing light, healing, sun, calmness, art, and spirit, in the municipality for the month of June.

NOW THEREFORE: I, Mayor Lowry, do hereby proclaim June 2023 as "June is PRIDE Month" in Mississippi Mills, and encourage our residents to reflect on the ongoing struggle for equality that members of the 2SLGBTQIA+ community face and to celebrate their contributions that enhance our municipality.
