DEPARTMENT HIGLIGHTS:

During the 4th Quarter, October, November and December 2023, the Roads and Public Works department, prepared for the challenges of the winter season. In addition to preparing equipment and Roadways, the Public Works department onboarded 3 seasonal staff members. Staff also developed and implemented an Inquiry tracker system utilizing the GIS system, to track and ensure follow up on inquiries of a nature that would require review and consideration for resolution.

Staff also dedicated significant time to the Water and Wastewater Service Delivery Review, Water and Wastewater Master Plan and Transportation Master Plan.

Under the direction of the Chief Building Official (CBO), an exclusionary zone was put in place around 38 Main Street. This required the installation of a road closure on Main Street in the area immediately in front of 38 Main Street. This closure will remain in place until further direction by the CBO permitting a reduction in the area of the exclusionary zone, that will permit some or all of Main Street in front of 38 Main Street to be safely opened to the traveling public.

Water and Wastewater Items to be included in regular Quarterly DWQMS reports.

2023 PROJECT UPDATES/PENDING ITEMS:

Key Projects

1. Downtown Core

Works were substantially completed, outstanding works to be finished in 2024 include removal and replacement of PXO's in downtown core. Works to be completed in spring/early summer 2024.

2. Outfall From Sewage Treatment Plant

Tree Removal around outfall with replacement trees being planted at a safer distance delayed due to weather, to occur spring 2024.

3. Water and Wastewater Service Delivery Review

Works related to the Service Delivery Review wrapped up with a draft report and recommendations being presented to Council. Final Report to be presented in 2024.

4. Princess Street Renewal


Works Substantially Completed, Some minor landscaping and deficiencies to be completed Spring 2024.
