SUBJECT: Department of Roads and Public Works Quarterly Report – Q2

DEPARTMENT HIGLIGHTS:

During the 2nd Quarter, April, May and June of 2024, the Roads and Public Works department dealt with the challenges of cleaning up after the winter season. This included activities such as street sweeping, line painting, grading gravel roads, and other general maintenance activities.

The initial clean up with the street sweepers often takes place over a short period of time with several sweepers in town to complete the works. The initial clean for 2024 was equivalent to 18 days of sweeping. Once the initial clean up is completed, maintenance sweeping is completed by a single sweeper 1 day per week completing a small portion of the Municipality each week.

The equivalent of 75 working days were spent grading over 180 km of gravel roads in Q3. In addition, approximately 25,000 tonnes of maintenance gravel was placed. This is equivalent to 1,190 tri-axle (dump truck) loads of gravel. It should be noted that in this reporting period there were 45 days with rain events impacting road conditions and the ability to complete grading activities.

As part of the department's responsibilities for Beautification, Public Works cleaned up and maintained several pathways, flower beds, and 90 Hanging baskets have been installed and maintained daily.

A total value of approximately \$8,471,450.00 in Major Capital works were tendered, awarded and works initiated. Major projects started include Union Street Reconstruction, Mercer and Marshall Street Reconstruction and Concession 9 North Pakenham Renewal. Additional smaller projects are not included in this list.

The exclusionary zone allowing the partial reopening of Main St, in front of 38 Main using temporary traffic lights to permit 2 way traffic through a single lane remains in place. The general arrangement will remain in place until further direction is given by the CBO.


