2025 PROJECT UPDATES/PENDING ITEMS:

During the second quarter, the Clerk's department was focused heavily on managing two public information centres relating to MM2048. The two PICs were held in Almonte and Pakenham and focused on obtaining important feedback from the public on key municipal projects. Strong Mayor Legislation also came into effect for Mississippi Mills on May 1, 2025, which has impacts on municipal operations and practices. The Clerk's department providing information to Council and staff as well as brought forward amended policies for approval in order to be compliant with the legislation. The Clerk's department will continue to take a lead role in adhering to the requirements of the Strong Mayor Legislation.
