G. <u>BUSINESS ARISING OUT OF MINUTES</u>

G.1 Off Street Dog Park

Calvin Murphy, Recreation Manager, gave a status update on the Off-Street Dog Park. He confirmed that the survey questions and communications plan would be brought back, in a timely fashion, to the Parks and Recreation Advisory Committee for final approval.

H.1 Adopt a Park Policy

On request of an Advisory Committee member, Calvin Murphy provided some background information on the creation of the policy, noting that Don Maynard Park had been adopted. H.2 Mill Run Park Development

The tender for this project closed on February 23, 2021. A report is being prepared for Council approval with construction to be undertaken in the Spring/Summer 2021.

H.3 Community Services Master Plan

Calvin Murphy, Recreation Manager, gave the committee a brief overview of the Community Services Master Plan. The plan forms part of the Municipality's Strategic Plan developed to assist Council and staff in setting priorities and making decisions that will impact our community for years to come.

The Community Services Master Plan will involve an in-depth review of Culture and Recreation, Library and Childcare to gain a shared understanding of these community focused services and what impact they will have on future municipal planning and development.

H.4 Canada Healthy Community Initiatives Grant

The Healthy Communities Initiative is a \$31 million investment from the Government of Canada to transform public spaces in response to COVID-19. Calvin Murphy, Recreation Manager, confirmed that he has not applied for funding under this grant program; however, he may look at applying in the coming months to assist with other projects.

Bridging Generations is looking to apply, in partnership with the municipality, for support of their plans for the Pakenham circuit trail. The Pakenham Trail initiative was referred to the Community and Economic Development Advisory Committee, by Council, in October 2019.
