D.1 Site Plan Control - Block 70, Riverfront Estates Subdivision

D.2 Official Plan Amendment (OPA) No. 29 – Agricultural Lands LEAR

Gabrielle Snow, consultant with JL Richards, provided an overview of the proposed amendment.

THAT Committee of the Whole recommend to Council to direct Staff to proceed with an Open House and Public Meeting for Official Plan Amendment (OPA) No. 29 in accordance with Planning Act notification procedures.

D.3 Official Plan Amendment (OPA) No. 22 - Almonte Settlement Area

Marc Rivet, Planning consultant with JLRichards, provided an overview of the proposed amendment. Council discussed the following items:

- Changes to the OPA 22 report from the previous report for all Areas
- Unidentified wetlands

- Timeline for OPA 22
- Council's role in the OPA 22 procedure

ACTION: Planning department to contact all property owners, or their representatives, of the 4 areas and advise them of the change in the Almonte Settlement Area Boundaries.

ACTION: Staff continue receiving comments from the public and circulating them to Council.

Council deferred the below motion to the April 6, 2021 Committee of the Whole meeting.

THAT Committee of the Whole recommends that Council adopts Official Plan Amendment No. 22 being an amendment to expand Almonte's Settlement Area Boundary including a series of policy updates as they relate to development within Almonte's Settlement Area. These expansion areas consist of Area 1 - revised ("Sonnenburg Lands") 14.9 ha, Area 2 ("Houchaimi Lands") 21.9 ha and Area 3A ("Henry Lands") 25.1 ha.

FURTHERMORE THAT Committee of the Whole recommends that Council include Area 4 ("Mill Run Extension") 8.9 ha to Almonte's Settlement Area Boundary as part of OPA 22 since OPA 26 (430 Ottawa St.) is under appeal and therefore should not be considered as 'designated and available' for the purpose of this Comprehensive Review. Furthermore, Area 4 would provide enough lands to meet a 20-year planning horizon as per OPA 21.

FURTHERMORE THAT Committee of the Whole recommends an Official Plan Amendment for lands located along the east side of Ramsay Concession 11A to be included within the Urban Settlement Area and to re-designate approximately 1.07 hectares of lands ("The Gaw Property") from "Rural" to "Highway Commercial" and re-designate approximately 1.71 hectares of land at 1728 Concession 11 A ("Cornerstone Community Church") from "Rural" to "Residential - Community Facility".

FURTHERMORE THAT Committee of the Whole recommends that Council direct staff to submit an Official Plan Amendment to the Lanark County Sustainable Communities Official Plan (County SCOP) to expand Almonte's Settlement Area Boundary. Motion No CW094.-21 Moved by Councillor Dalgity Seconded by Councillor Holmes

THAT the Committee of the Whole defer OPA 22 - Almonte Settlement Area report to the April 6, 2021 meeting;

AND THAT Staff be directed to accept comments from the public on the OPA 22 until that time;

AND THAT Staff be directed to circulate all public comments received for OPA 22 to Council.
