AND FURTHERMORE THAT Committee of the Whole recommend that Council authorize the final release of securities totaling \$312,969.00 in accordance with Section 23 of the subdivision agreement(s);

AND FURTHERMORE THAT Committee of the Whole direct staff to prepare an assumption by-law for the roads and associated infrastructure works constructed with the development of plan of subdivision 27M-58, 27M-63 and 27M-71.

F.3 Zoning By-law Amendment Z-02-20 Lot 11 and 12, PLAN 6262 Almonte Ward

THAT Committee of the Whole recommend that Council approve the Zoning By-law Amendment to change the zoning on the lands known as 143 Marshall Street, Almonte Ward, Municipality of Mississippi Mills from "Residential Second Density (R2)" to "Residential Third Density – Special Exception Holding (R3-xh)", where the special exception will prescribe: a minimum lot area of 160m²; a minimum exterior side yard setback of 3m; a minimum rear yard setback of 6m; maximum lot coverage of 65%; and a maximum net density of 55 units per ha, subject to a holding provision pending the submission of a Stormwater Management Report to the satisfaction of the Mississippi Valley Conservation Authority and the Municipality of Mississippi Mills.

F.4 Zoning By-law Amendment Z-06-20, Part Lot 27, Plan 6262

THAT Committee of the Whole recommend that Council approve the Zoning By-law Amendment to amend the zoning on the lands known legally as Part Lot 27, PLAN 6262 on Farm Street in Almonte Ward, Municipality of Mississippi Mills from "Downtown Commercial" (C2) to "Downtown Commercial – Special Exception (C2-x), where the special exception will add triplex, fourplex and ground floor residential uses up to 50% of the gross floor area at the rear of the building as additional permitted uses, and recognize the following site specific exception provisions: minimum setback between a parking space and a habitable room window of 1.37m; minimum setback between a driveway aisle and a habitable room window of 0m.

THAT Committee of the Whole recommend that Council approve the Zoning By-law Amendment to change the zoning on part of the lands known Municipally as 101 Lynx Hollow, Pakenham Ward, Municipality of Mississippi Mills from "Rural" (RU) to "Limited Service Residential- Special Exception" (LSR-x) to permit agricultural uses in addition to those uses permitted in the LSR Zone.

G.4 Safety on Gravel Roads

Councillor Dalgity resumed as Chair

Resolution No CW092-20 Moved by Councillor Holmes Seconded by Councillor Guerard

WHEREAS there has been a number of complaints received relating to traffic speeds and pedestrian safety on gravel roads where the speed limits are not posted;

AND WHEREAS the speed limit on the majority of gravel roads is 80 km/hour;

AND WHEREAS as part of the draft Strategic Plan Council prioritized Vision Zero to improve pedestrian safety of municipal roads;

THEREFORE BE IT RESOLVED THAT the Committee of the Whole directs the Roads and Public Works Department to investigate solutions to address enhancing pedestrian safety on gravel roads and to bring forward a report to Committee of the Whole with options for consideration.

G.5 MVCA - Funding for the Water and Erosion Control Infrastructure (WECI) program

Resolution No CW093-20 Moved by Councillor Holmes Seconded by Mayor Lowry

WHEREAS the province reaffirmed its commitment to "continue its cost share funding arrangement with municipalities...to support high priority repairs to conservation authority infrastructure" in its March 2020 Ontario Flooding Strategy;

AND WHEREAS the province allocated \$5 million annually for this purpose in 2003 and has not increased or indexed the funding envelop in 17 years;

AND WHEREAS demand for replacement and upgrade of water and erosion control assets is ever increasing due to aging infrastructure and the impacts of climate change;

AND WHEREAS critical infrastructure within the Mississippi Valley watershed that serves this municipality did not receive funding this year and there are no guarantees that it will in the foreseeable future based upon current program demand;

AND WHEREAS, should funding not be received from the province for these and other MVCA capital projects the burden of those costs will fall in part to this municipality;

NOW THEREFORE BE IT RESOLVED the CAO be directed to draft a letter on behalf of Council for submission to the Minister of Natural Resources and Forestry, the Minister of Environment, Conservation and Parks, and the Minister of Municipal Affairs and Housing supporting the letter from the MVCA and requesting that funding of the Water and Erosion Control Infrastructure (WECI) program be significantly increased and that program rules be adjusted to allow for reasonable construction periods and the carry- over of funds between fiscal years.
