Highlights include: opportunities for improvement; creating a clear road map; modernizing services; productivity savings; asset management and long term financial planning; HR capacity; communications (internal and external); improved flow of information; governance; advisory committee structure; target operating model; and priority initiatives.

Members posed questions to the consultants highlights include: how recommendations will be prioritized (cost savings vs efficiencies); committee structure; reserves policy; sharing resources with County; asset management; growth and diversifying assessment base; by-law enforcement; water and sewer rates; capital expenses; police services; recreation and outdoor spaces; recreation programming and cost recovery; fire service and managing provincial compliance; available land for development; debt per household; municipal debt; time frame for asset management plan and financial plan in place; multi-year budgeting; economic development strategy; organization chart changes; role of Council (operational vs policy); additional revenue streams; and facilities management role.
